BUPATI LUWU UTARA,

Menimbang : bahwa untuk melaksanakan ketentuan Pasal 7 Peraturan Bupati Luwu Utara Nomor Tahun 2017 tentang Tata Cara Pembagian dan Penyaluran Besaran Alokasi Dana Desa, Pajak Daerah dan Retribusi Daerah Bagian Pemerintah Desa Se Kabupaten Luwu Utara dan ketentuan Pasal 7 Peraturan Bupati Luwu Utara Nomor Tahun 2017 tentang Tata Cara Pembagian dan Penetapan Rincian Dana Desa setiap Desa Kabupaten Luwu Utara Tahun Anggaran 2017, perlu menetapkan Peraturan Bupati tentang Penetapan Pagu Sementara Alokasi Dana Bagian Pemerintah Desa Se Kabupaten Luwu Utara Tahun Anggaran 2017.

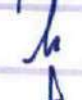
Pasal 1
